#### Seller and Buyer agree to the terms on front and on reverse hereof:

- 1. This document is intended as the entire agreement. It supersedes all prior agreements, written or oral and may not be modified orally. Buyer is notified thereby that unless agreed to in writing signed by Seller, any altered or additionnal terms proposed by Buyer are deemed immediately objected to by Seller.
- 2. All sales are DDP USA (delivery duty paid), to Buyer confirmed delivery address, and this transaction is made to be performed in the US.
- 3. Payment terms available are 30 days net with approved credit via bank transfer, by check or CC (Visa or Mastercard). Customers whose credit has not been approved by our company are deemed to pay by proforma (advanced payment). Penalty charges of US\$ 50.00 will be charged for every bounced check.
- 4. Penalty charge will be applied monthly on all delayed payment, interest rate is calculated according to the practice of American business laws.
- 5. Any customer with unpaid invoices over 120 days from the due date will be subject to credit Insurance black list for a period of 2 years from the date of the deliquent payment original due date. Proforma/ advanced payment will be requested over a period of 2 years starting from the date of the payment original due date.
- 6. Property of the goods remains to the Seller until the payment has been made by Buyer.
- 7. Any claims or request to return goods must be made to Seller in writing within FIVE (5) business days of the date Buyer receives goods, as shown on the carrier's delivery receipt. No claim may be made or return approved beyond that time limit. No credit shall be valid unless approved by the seller in writing. Buyer agrees to bear the cost of returning the goods of non defective products. No goods may be returned in any case whithout the written approval from Seller. All non defective items are subject to a restocking charge. No cash refund on returns, credit or exhange only.
- 8. Seller may decline to do future business with Buyer without reason and Seller can decline any reorders from Buyer. Buyer represents to Seller that Buyer is purchasing the goods sold hereunder exclusively for resale from Buyer's stores to retail consumers. Buyer aknowledges that Seller has accepted Buyer's order in reliance on this representation.
- 9. Seller shall not be liable for any defect, delay, or non delivery if such results from act of God, riot, war, civil unrest, embargo, seizure, fire, flood, explosion, accident, earthquake or other cause beyond Sellers's reasonnable control.
- 10. The goods are purchased on an "as-is" basis and no implied representations or warranties are intented or made by Seller. No statement or promise have been made on by or on behalf of Seller to induce Buyer to enter into this Agreement except those specifically set forth.
- 11. The parties agree that all actions arising in connection with this agreement shall be litigated under the US federal laws.
- 12. If any term hereof is determined to be illegal, unenforceable, or invalid, such term shall be deemed stricken and not affect the enforceability or validity of the other terms. Each party represents and warrants to the other that the making of this Agreement has been duly authorized and that it is valid, binding and enforceable according to its terms.
